2010 Arte Del Barrio Competition OFFICIAL CONTEST RULES

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN

1. **CONTEST DESCRIPTION:** Visual Art Contest is a contest in which entrants above the age of 16 years old and may submit their art work. Art work must be original and unpublished. Submission Requirements:

- (1) Must have a title,
- (2) Must be your own work,
- (3) Cannot take any elements from any other artists pieces,
- (4) One (1) submission per entrant.

2. **HOW TO ENTER:** To enter, submit artwork with the information required at 5209 Detroit Avenue Cleveland, Ohio 44102. Before submission or being awarded a prize, La Cosecha Galleria will verify the contest entrants identity, including with name, address, city, state, zip code, age, phone number (including area code), and e-mail address. La Cosecha Galleria reserves the right to not award prizes to entrants that do not meet eligibility requirements and/or who do not provide sufficient proof of identity. Entries must include a valid e-mail address. must be received by 11:59:59 PM Pacific Time on 4/30/2010. Sponsor reserves the right to remove any submission from the website that is illegal, obscene, indecent, offensive, or any other imagery deemed to be an inferior submission in the Sponsor's opinion. Sponsor and its agents are not responsible for incorrect, lost, late, misdirected, damaged, incomplete, or illegible entries.

3. **WINNER SELECTION:** Judging will be based upon creativity and originality. In the event of a tie an independent judge will choose a winner and their decisions are final on all matter relating to the contest. If any of the eligible entries in the opinion of the judges is deemed to be an inferior submission it will be considered ineligible. Winners will be notified on or about May 8th, 2010 during the opening.

4. PRIZE AND PRIZE VALUES: One (1) Grand Prize will be awarded: \$500 cash, One (1) 2nd Place Prize will be awarded: \$250 cash, and One (1) 3rd Place Prize will be awarded: \$100 cash. Total retail value of all prizes \$850. All taxes and any expenses not expressly mentioned above as being paid by Sponsor are the winner's responsibility.

5. ELIGIBILITY: This contest is open to legal residents of the United States who are above the age of 16 years old on the date of entry. Employees of Sponsor, their affiliates, subsidiaries, dealers, distributors, retailers, advertising and production agencies, and their immediate families and residents of their households are not eligible.
